Scope

The University of Queensland (UQ or the University) Ethics Advisory Group provides a consultative resource for review of ethical matters that arise from activities of the University that are <u>not related</u> to human research ethics and the approval of research projects. The group has a focus on provision of advice related to:

- A. The School of Anatomy and its operations.
- B. The use of UQ's corporate data for non-research purposes.
- C. Non-research consultancy activities.
- D. Quality assurance and evaluation activities that cannot be reviewed by a human research ethics committee.
- E. Other matters of ethics concern to the University.

What we do

The Ethics Advisory Group aims to promote and support ethical decision making by reaching consensus on the ethical acceptability of a matter. The Group may provide options, considerations, and strategies to help requestors work through ethical issues and concerns, and to assist them to make sound judgements and choices. The Ethics Advisory Group does not provide an avenue for reporting, handling or investigating grievances or cases of suspected misconduct.

The Ethics Advisory Group is not an approval body and it does *not* provide legal advice. Any decision or action taken on the basis of advice provided by the Ethics Advisory Group is the responsibility of the individual.

What we need from you

This form is a mandatory component of submission for the consideration of the Ethics Advisory Group. The form provides an opportunity to explain the background, rationale and any previous advice sought in relation to a matter being submitted for the Group's consideration. In completing this form please use plain language, defining all technical terms and avoiding acronyms.

We provide confidential advice and respect your right to remain anonymous. The information collected will be stored, used and disclosed in accordance with UQ's Privacy Management Policy.
